- The operations of the company were adversely affected mainly by (a) increase in cotton cost due to minimum support price and (b) continued power cut, load shedding and peak hour restriction.
- The Company is principally engaged in a single business segment viz., cotton yarn and operates in a single geographical segment.
- During the quarter, no investor complaints were received nor pending for redressal at the beginning and end of the quarter.
- The above financial results were reviewed by the Audit Committee and then approved by the Board of Directors at its meeting held on October 31, 2009. The Statutory Auditors have conducted a limited review of the above results.
